FIRST ANNEXATION AMENDMENT TO MASTER DECLARATION OF COVENANTS, CONDITIONS, EASEMENTS AND RESTRICTIONS FOR POWDER MOUNTAIN

THIS FIRST ANNEXATION AMENDMENT TO MASTER DECLARATION OF COVENANTS, CONDITIONS, EASEMENTS AND RESTRICTIONS FOR POWDER MOUNTAIN ("Annexation"), dated as of February 3, 2016, is made and executed by Summit Mountain Holding Group, L.L.C., a Utah limited liability company ("Master Developer") for itself, its successors and assigns.

RECITALS

- A. Master Developer executed that certain Master Declaration of Covenants, Conditions, Easements and Restrictions for Summit Eden, recorded in the Official Records of Weber County on January 27, 2014 as Entry No. 2672941, as amended by that certain First Amendment to Master Declaration of Covenants, Conditions, Easements and Restrictions for Powder Mountain (Formerly known as Summit Eden), recorded in the Official Records of Weber County on October 1, 2014 as Entry No. 2704954, as further amended by that certain Second Amendment to Master Declaration of Covenants, Conditions, Easements and Restrictions for Powder Mountain, recorded in the Official Records of Weber County on November 25, 2014 as Entry No. 2712001 (collectively, the "Master Declaration").
- B. Pursuant to Article 15 of the Master Declaration, Master Developer reserved the unilateral right and option to expand the Community by adding to the Community the Additional Land or a portion or portions thereof ("Option to Expand"), without obtaining the vote or consent of any other person (including any Owner or Mortgagee).
- C. Master Developer desires to exercise its Option to Expand by adding to the Community the Additional Land described in Exhibit "A". Master Developer shall be the Owner of that portion of the Additional Land annexed by the exercise of the Option to Expand.

NOW, THEREFORE, MASTER DEVELOPER hereby declares, covenants and agrees as follows:



- 1. <u>Defined Terms and Status of Recitals</u>. Capitalized terms used and not otherwise defined in this Annexation shall have the meaning or meanings given to them in the Master Declaration. The Recitals set forth above shall constitute a portion of the terms of this Annexation and are hereby incorporated by this reference.
- 2. Exercise of Option to Expand. Master Developer hereby exercises its Option to Expand the Community pursuant to Article 15 of the Master Declaration, and adds to the Community the Additional Land described in Exhibit "A," together with the improvements located thereon or to be located thereon. Master Developer declares that from and after the date set forth below, the Additional Land described in Exhibit "A" is now subject to, and governed by, the provisions of the Master Declaration and any amendments or supplements thereto, and shall hereafter be held, transferred, sold, conveyed, and occupied subject to the covenants, restrictions, easements, charges, and liens set forth in the Master Declaration.
- 3. Annexation of Property in Cache County. Master Developer further desires to exercise its Option to Expand the Community with respect to certain Additional Land located in Cache County, Utah as more particularly described in Exhibit "B" attached hereto. To effectuate such expansion and document the inclusion of such property in the Community, Master Developer shall record the Master Declaration in the Official Records of Cache County, Utah. The property described in such recorded document shall thereafter be subject to, and governed by, the provisions of the Master Declaration and any amendments or supplements thereto, and shall thereafter be held, transferred, sold, conveyed, and occupied subject to the covenants, restrictions, easements, charges, and liens set forth in the Master Declaration.
- 4. <u>Title to Land and Developmental Rights</u>. Title to the Additional Land described in Exhibit "A" and Exhibit "B" shall remain vested with Master Developer until such time as Master Developer conveys all or a portion thereof to a third party. Master Developer reserves all developmental rights described in the Master Declaration with respect to such Additional Land.
- 5. <u>Master Declaration Remains in Effect</u>. This Annexation shall be considered supplemental to the Master Declaration. This Annexation shall be considered a Supplemental Declaration for all purposes under the Master Declaration. Except as expressly amended by the foregoing, the Master Declaration shall remain in full force and effect and shall not be canceled, suspended or otherwise abrogated by the recording of this Annexation.
- 6. <u>Master Developer Rights</u>. Master Developer shall retain all rights of Master Developer as set forth in the Master Declaration, and this Annexation shall neither amend nor abrogate such rights, except as specifically provided for herein.
