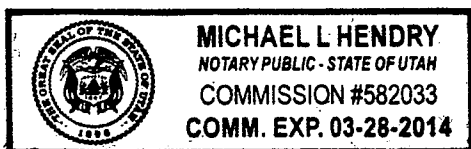

A PART OF THE SOUTHWEST QUARTER OF SECTION 17, TOWNSHIP 4 NORTH, RANGE 1 WEST: BEGINNING AT A POINT WHICH IS 154.41 FEET EAST ALONG THE SECTION LINE AND 33 FEET NORTH FROM THE SOUTHWEST CORNER OF SAID SECTION 17, RUNNING THENCE TWO COURSES ALONG THE EASTERLY LINE OF A 6 INCH CONCRETE CURB AS FOLLOWS: NORTH 4 DEG 05 MIN 30 SEC WEST 188.87 FEET AND NORTH 47 DEG 32 MIN 52 SEC EAST 91.53 FEET TO THE SOUTHWESTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY, THENCE SOUTHEASTERLY ALONG ARC OF A 5779.6 FOOT RADIUS CURVE TO THE RIGHT 305.61 FEET (LC BEARS SOUTH 40 DEG 24 MIN 47 SEC EAST 328.56 FEET) ALONG SAID LINE, THENCE SOUTH 25 DEG 33 MIN 53 SEC WEST 19.84 FEET, THENCE WEST 244.06 FEET TO THE POINT OF BEGINNING.
