# AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR THE EXCHANGE IN LEHI CONDOMINIUMS

This Amendment to the Declaration of Condominium for The Exchange in Lehi Condominiums (the "Amendment") is executed and adopted by Edge Exchange, LLC (the "Declarant").

## **RECITALS**

- A. The Declaration of Condominium for The Exchange in Lehi Condominiums was recorded on April 12, 2017 as Entry No. 35362:2017 in the office of the Utah County Recorder (hereinafter the "**Declaration**").
- B. This Amendment affects the real property located in Utah County, State of Utah, described with particularity on Exhibit A, which exhibit is attached hereto and incorporated herein by reference.
- C. The Declarant desires to amend the Declaration as set forth in this Amendment to add automobile and recreational vehicle parking regulation provisions.
- D. Unless otherwise set forth herein, the capitalized terms shall have their same meanings and definitions as stated in the Declaration.
- E. Pursuant to Article 15, Section 15.1(a) of the Declaration, the Declarant has the sole authority to amend the Declaration during the Period of Declarant Control. As of the date of the recording of this Amendment, the Period of Declarant Control remains in effect.

#### **AMENDMENTS**

- **NOW, THEREFORE**, in consideration of the foregoing Recitals, the Declarant hereby executes this Amendment, which shall be effective as of its recording date with the Utah County Recorder's office.
- (1) <u>Amendment No. 1</u>. The following shall be added as Article 9, Section 9.25 of the Declaration:
- 9.25 Recreational Vehicles. The parking in the Project is limited. Therefore, no boats, trailers, motorhomes, trucks larger than a "one-ton" classification, commercial vehicles, camping trailers, ATVs, snowmobiles, recreational vehicles, or the like (herein "RVs") belonging to Owners or Occupants of the Project shall be parked within the Project other than for temporary loading and unloading. Temporary loading and unloading of RVs must be conducted in the Owner's driveway only, and any parking of RVs in a driveway is limited to a maximum of 24 hours. RVs parked in the streets or Common Area parking stalls are subject to immediate towing without notice to the Owner or

Occupant. RVs shall not be parked in an Owner's enclosed garage, as such parking is intended for parking of the Occupant's automobile. The Board is hereby empowered to establish additional Rules relating to the parking of RVs within the Project that may expand the restrictions set forth in this Section. The Association is not obligated to treat all areas equally and may adopt different parking rules for different areas or streets within the Project. Rules relating to the parking of RVs may include, but are not limited to: (1) restrictions on the time period and duration of parking in certain areas, (2) restrictions on garage storage that obstructs the full parking capacity of the garage, (3) the designation of "no parking" areas, (4) Rules allowing the removal of any RVs that are improperly parked including fees for such removal, (5) the authority to assign common area parking spaces and collect fees for such use, and (6) the assessment of fines to Owners (or their guests and Occupants) who violate the Rules. The Association shall have the right to perform ongoing inspections of Owner's driveways and garages to ensure compliance with this Section or any Rules adopted pursuant to this Section.

- (2) <u>Conflicts</u>. All remaining provisions of the Declaration and any prior amendments not specifically amended in this Amendment shall remain in full force and effect. In the case of any conflict between the provisions of this document and the provisions of the Declaration or prior amendments, the provisions of this document shall in all respects govern and control.
- (3) <u>Incorporation & Supplementation of Declaration</u>. This document is supplemental to the Declaration, which by reference is made a part hereof, and all the terms, definitions, covenants, conditions, restrictions, and provisions thereof, unless specifically modified herein, are to apply to this document and are made a part hereof as though they were expressly rewritten, incorporated, and included herein.
