AMENDMENT TO DECLARATION  
HIDDEN LAKE CONDOMINIUM

KNOW ALL MEN BY THESE PRESENTS:

Reference is made to that certain Declaration of Covenants, Conditions, Restrictions, and By-Laws, for Hidden Lake Condominium dated May 31, 1974 and recorded May 31, 1974 in Book 3599 at Page 455 as Instrument No. 2625963 of the Records of the Salt Lake County Recorder pursuant to the provisions of the Utah Condominium Ownership Act, Section 57-8-1, et, seq.;

Specific reference is made to paragraph 24 of said declaration wherein provision is made for amendment thereto. The undersigned constituting the current management committee referred to in said paragraph 24 hereby certify that a meeting of the Homeowners Association as therein described was held on February 5, 1975 at which meeting ownership representing more than two-thirds of the undivided interests in the common areas and facilities were present and voted in the affirmative in favor of a motion to change the garage assignments as herein set forth. 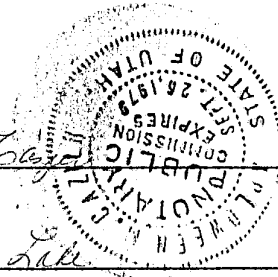
