AMENDMENT TO THE PROTECTIVE COVENANTS FOR RIVERVIEW EAST SUBDIVISION recorded February 17, 1976 in book 4106 at page 48 as Entry No. 2785966 according to the records of the Recorder of Salt Lake County, State of Utah.

Paragraph B-3 DWELLING COST, QUALITY AND SIZE shall be amended to read as follows:

No dwelling shall be permitted on any lot at a cost of less than \$28,000.00 based upon the cost levels prevailing on the date these covenants are recorded, it being the intention and purpose of the covenants to assure that all dwellings shall be of quality of workmanship and materials substantially the same or better than that which can be produced on the date these covenants are recorded at the minimum cost stated herein for the minimum permitted dwelling size. The area of the ground or main floor for a dwelling shall not be less than 900 square feet provided, however, that in addition it contains a two car attached garage. Otherwise, it shall contain not less that 1,100 square feet if the dwelling provides a single car garage or carport. A 1½ or 2 story dwelling providing a garage under shall contain not less than 1,100 square feet of main floor area.

B-4 BUILDING LOCATION shall be amended to read as follows:

No building shall be located on any lot nearer than 25 feet to the front line, or nearer than 20 feet to any side street line, or nearer than 8 feet to any interior lot line. The minimum distance from the main building to the rear lot line shall be 15 feet. For the purpose of this covenant, eaves, steps, and open porches shall not beconsidered as a part of the building, provided, however, that this shall not be construed to permit any pontion of a building on a lot to encroach upon another lot. A detached garage and/or carport or other permitted accessory building may be located next to a side lot line as long as it is 40 feet from the minimum building setback line and is on an interior lot.

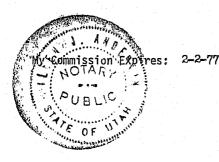
