

A parcel of land being a portion of Lot 1 and Lot 8, Block 80 of Plat "A", Salt Lake City Survey, Salt Lake City, County of Salt Lake, State of Utah, said Plat "A" recorded in Book "B" pages 13-20 of Plats, Records of said County, and that portion of Third West Street (now Fourth West Street) vacated by Salt Lake City, by Ordinance dated September 28, 1903, O.S.L. L.P. D.A. No. 2164, said parcel is more particularly described as follows:

Commencing at the City Monument located at the intersection of First South Street and Fourth West Street (formerly Third West Street:
