## AMENDMENT TO RESTRICTION AGREEMENT

WHEREAS, American Land Company, Inc., a Utah corporation, with its principal place of business at Salt Lake City, Utah, as the owner of all of the Brookside Park Subdivision as recorded in the office of the County Recorder of Utah County, State of Utah, executed a restriction agreement involving the whole of said land, which agreement was dated September 25th, 1943, and recorded September 29th, 1943, at 2:12 o'clock P.M. as Entry #10243 in Book 385, pages 91 and 94 in the office of the County Recorder of Utah County, State of Utah, and

WHEREAS, it is now found that an error was contained in line four (4), paragraph ll, entitled "Planting Strip", of said Agreement, in that the word "northerly" should have read "southerly", and it is the desire of American Land Company, Inc., to rectify said error,

NOW, THEREFORE, in consideration of the premises, paragraph 11 of said restriction agreement entitled "planting strip", hereinbefore referred to, is amended to read as follows:

"ll. PLANTING STRIP: That as to lots abutting East 4th South Street, no building, nor any driveway nor any other structure shall be placed or maintained between the Southerly line of East 4th South Street and a line running parallel thereto and a distance of ten (10) feet Southerly therefrom. Said 10 foot strip of ground running parallel to said street shall be used exclusively for the planting of trees and shrubs. Ingress and egress over said 10 foot strip of ground is prohibited except for the purposes of installation and maintenance of plant material."

all other provisions of said Restriction Agreement to remain in full force and effect.
