## ORDINANCE

AN ORDINANCE, AMENDING TITLE XXII, OF THE REVISED ORDINANCES OF SALT LAKE COUNTY, AS AMENDED, CHANGING CERTAIN PROPERTY IN SALT LAKE COUNTY FROM AGRICULTURAL ZONE A-20 TO MANUFACTURING ZONE M-2

The Board of County Commissioners of Salt Lake County, State of Utah, ordains as follows:

Section 1: Section 22-8-4, Revised Ordinances of Salt Lake County, 1966, as amended, is hereby amended as follows:

The property described in Application #2459, filed by John A. Rokich and Jeannine C. Rokich and located in Salt Lake County is hereby reclassified from Agricultural Zone A-20 to Manufacturing Zone M-2, said property being described as follows:


Commencing South 89 degrees 54' East 668.79 feet from the South Quarter corner of Section 16, Township 1 South, Range 2 West, Salt Lake Base and Meridian; thence South 89 degrees 54' East 1497.48 feet more or less; thence North 00 degrees 02' West 875.12 feet more or less; thence South 89 degrees 53' 30" East 466.7 feet more or less; thence North 00 degrees 02' West 233.7 feet more or less; thence North 89 degrees 53' 30" West 466.7 feet more or less; thence North 00 degrees 02' West 233.0 feet more or less; thence North 89 degrees 53' 20" West 1472.9 feet more or less; thence South 00 degrees 22' 13" East 1342.36 feet more or less to the point of beginning. Containing approximately 46.52 acres

Section 2: The map showing such change shall be filed with the Salt Lake County Planning Commission in accordance with Section 22-8-2 of the Revised Ordinances of Salt Lake County, 1966, as amended.

Section 3: This ordinance shall become effective and in full force on the 26th day of November, 1976.
