

CERTIFICATE OF SURVEYOR.

I HEREBY CERTIFY THAT THE TRACT OF LAND SHOWN ON THIS DIAGRAM AND OWNED BY GEORGE E. YEARDON, HENRIETTA YEARDON HIS WIFE, AND ELIZABETH GABBOTT IS BOUNDED AND DESCRIBED AS FOLLOWS TO WIT: BEGINNING AT THE SOUTH-WEST CORNER OF LOT EIGHT (8) IN BLOCK 11 IN FIVE ACRE PLAT "A", BIG FIELD SURVEY, AND RUNNING NORTH SEVEN HUNDRED AND FORTY-SIX AND THIRTY-SEVEN ONE-HUNDREDTH ($746\frac{37}{100}$) FEET; THENCE EAST SEVEN HUNDRED AND ELEVEN AND FIFTY-TWO ONE-HUNDREDTH ($711\frac{52}{100}$) FEET; THENCE SOUTH SIX AND NINE-TENTH ($6\frac{9}{10}$) FEET; THENCE EAST SEVEN HUNDRED AND SEVENTY-THREE AND FORTY-EIGHT ONE-HUNDREDTH ($773\frac{48}{100}$) FEET; THENCE SOUTH SEVEN HUNDRED AND THIRTY-NINE AND FORTY-SEVEN ONE-HUNDREDTH ($739\frac{47}{100}$) FEET; THENCE WEST FOURTEEN HUNDRED AND EIGHTY-FIVE (1485) FEET TO THE PLACE OF BEGINNING, CONTAINING TWENTY-FIVE AND THIRTY-TWO ONE-HUNDREDTH ($25\frac{32}{100}$) ACRES, AND IS NOW KNOWN AS LOTS 8, 9, 14 AND 15, AND PART OF LOTS 10 AND 13 IN BLOCK 11 IN FIVE ACRE PLAT "A", BIG FIELD SURVEY, AND THAT I HAVE BY REQUEST AND AUTHORITY OF THE SAID OWNERS THEREOF SUBDIVIDED THE SAME INTO LOTS, STREETS, AVENUES AND ALLEYS, TO BE KNOWN AS SOUTH MAIN STREET ADDITION, PLAT "A", AND THAT THE SAME HAVE BEEN CORRECTLY STAKED OUT ON THE GROUND AS REPRESENTED HEREON.

THE FOLLOWING ARE THE NAMES AND DIMENSIONS OF PARCELS DESIGNATED FOR PUBLIC USE, TO WIT: WEST TEMPLE STREET TEN (10) FEET WIDE, AND RUNNING SEVEN HUNDRED AND FORTY-SIX AND THIRTY-SEVEN ONE-HUNDREDTH ($746\frac{37}{100}$) FEET NORTH AND SOUTH; FREMONT AVENUE EIGHTY-TWO AND FIVE-TENTH ($82\frac{5}{10}$) FEET WIDE AND RUNNING SEVEN HUNDRED AND FORTY-SIX AND THIRTY-SEVEN ONE-HUNDREDTH ($746\frac{37}{100}$) FEET LONG NORTH AND SOUTH; MAIN STREET ONE HUNDRED AND THIRTY-TWO (132) FEET WIDE, AND RUNNING SEVEN HUNDRED AND THIRTY-NINE AND FORTY-SEVEN ONE-HUNDREDTH ($739\frac{47}{100}$) FEET LONG NORTH AND SOUTH; MAJOR AVENUE EIGHTY-TWO AND FIVE-TENTH ($82\frac{5}{10}$) FEET WIDE AND RUNNING SEVEN HUNDRED AND THIRTY-NINE AND FORTY-SEVEN ONE-HUNDREDTH ($739\frac{47}{100}$) FEET LONG NORTH AND SOUTH; HEATH AVENUE THIRTY-ONE AND NINE-TENTH ($31\frac{9}{10}$) FEET WIDE AND RUNNING SEVEN HUNDRED AND ELEVEN AND FIFTY-TWO ONE-HUNDREDTH ($711\frac{52}{100}$) FEET LONG EAST AND WEST, CONTINUING EASTWARD ON SAME STREET SEVEN HUNDRED AND SEVENTY-THREE AND FORTY-EIGHT ONE-HUNDREDTH ($773\frac{48}{100}$) FEET LONG AND TWENTY-FIVE (25) FEET WIDE; GABBOTT AVENUE THIRTY-THREE (33) FEET WIDE, AND RUNNING FOURTEEN HUNDRED AND EIGHTY-FIVE (1485) FEET LONG EAST AND WEST.

ALL LOTS IN BLOCKS 3 AND 4 ARE 25 FEET BY $136\frac{25}{100}$ FEET, EXCEPT LOTS NUMBERED 28 AND 29 WHICH ARE $31\frac{25}{100}$ FEET BY $136\frac{25}{100}$ FEET. ALL LOTS IN BLOCKS 3 AND 4 ARE 25 FEET BY $141\frac{25}{100}$ FEET, EXCEPT LOTS NUMBERED 1 AND 2 WHICH ARE 30 FEET BY $141\frac{25}{100}$ FEET, AND LOTS NUMBERED 28 AND 29 WHICH ARE 26 FEET BY $141\frac{25}{100}$ FEET.
