FENCE LINE/OCCUPATION LINE AGREEMENT

This "Fence Line/Occupation Line Agreement" is entered into between and among <u>Brett G and Kristen A</u>

Ferrin and Cortney and Brooke Smith, adjacent property owners in Weber County, State of Utah.

In consideration of the mutual promises, covenants, and conditions contained herein the parties hereto agree as follows:

There currently exists a fence, asphalt paving, and concrete paving separating the real
property utilized by the foregoing property owners, which does not coincide with the recorded
deed line of the parties and which is described as follows:

LOCATED IN THE SOUTHWEST QUARTER OF SECTION 34, TOWNSHIP 7 NORTH, RANGE 2 WEST, OF THE SALT LAKE BASE AND MERIDIAN.

BEGINNING AT THE INTERSECTION OF AN EXISTING FENCE LINE AND THE NORTH BOUNDARY LINE OF WEBER COUNTY PARCEL NUMBER 19-304-0006 BEING LOCATED NORTH 89°34'13" WEST 675.58 FEET ALONG THE SOUTH LINE OF SAID SOUTHWEST QUARTER AND NORTH 00°00'00" EAST 1444.28 FEET FROM THE SOUTHEAST CORNER OF SAID SOUTHWEST QUARTER; RUNNING THENCE ALONG SAID EXISTING FENCE LINE AND OCCUPATION LINES INCLUDING CONCRETE AND ASPHALT DRIVEWAYS THE FOLLOWING FIVE (5) COURSES: (1) NORTH 01°03'09" EAST 85.21 FEET; (2) NORTH 00°32'06" EAST 98.11 FEET; (3) NORTH 00°15'18" EAST 144.13 FEET; (4) NORTH 03°11'05" EAST 54.35 FEET; (5) NORTH 00°38'37" WEST 95.67 FEET TO THE SOUTH RIGHT-OF-WAY LINE OF 2200 NORTH STREET AND THE POINT OF TERMINATION.

- 2. It is the intent of the parties that the foregoing described fence and occupation line shall supersede all recorded deed descriptions and shall henceforth be the agreed to recorded deed line of the parties affecting their respective adjoining properties.
- The parties agree that this fence and occupation line agreement shall be recorded with the Weber County Recorder as evidence of their agreement, as set forth above.
- 4. The parties agree to jointly maintain the existing fence line and other physical improvements.
- 5. The parties agree to execute any other documents which may be necessary to effectuate the foregoing.
