the State of Delaware, Grantor, hereby QUIT CLAIMS to the STATE ROAD COM-
MISSION OF UTAH, Grantee, for the sum of Three Hundred Seventy and
00/100 (\$370.00) Dollars, the following described
parcel of land in Tooele County, State of Utah, to-wit:

A parcel of land in fee for a connection road incident to the construction of
a freeway known as Project No. 80-2, being part of an entire tract of property,
in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 32, T. 1 S., R. 5 W., and in Lot 3 and Lot 4 of Section 5,
T. 2 S., R. 5 W., S.L.B.&M. The boundaries of said parcel of land are described
as follows:

Beginning at the SW. corner of said Lot 4; thence North 108 ft., more or less,
along the west line of said Lot 4 to a point 75.0 ft. perpendicularly distant
northwesterly from the center line of said connection road; thence N. 51°47'45" E.
2075 ft., more or less, to a point 75.0 ft. perpendicularly distant northwesterly
from said center line at Engineer Station 332+38.85; thence S. 38°12'15" E.
150.0 ft.; thence S. 51°47'45" W. 2058 ft., more or less, to the south line of
said Lot 4; thence West 105 ft., more or less, along said south line to the point
of beginning as shown on the official map of said project on file in the office
of the State Road Commission of Utah. The above described parcel of land contains
7.25 acres, more or less.

reserved by the Grantor, and the Grantee shall not be liable for any water
assessments now due or which shall become due.
