

GRANT OF EASEMENT

Ramah Crystal Sharpstone owner of the land described herein, and for consideration received, the receipt and sufficiency of which is acknowledged, does hereby acknowledge, grant, bargain, sell and convey to Uintah Basin Telephone Association of P.O. Box 398, Roosevelt, Utah 84066 an easement and right-of-way to erect, construct, re-construct, replace, remove, maintain and use a telephone line or lines or other communication line or lines with such wires, cables or other facilities for the transmission of communications or other information and other communications purposes.

The above referred to right-of-way is located in Duchesne County, State of Utah and is described as follows:

The S $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 28, Township 2 North, Range 4 West, Uintah Special Meridian.

Beginning at a point on the west boundary of the S $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 28, Township 2 North, Range 4 West, Uintah Special Meridian, said point bears N. 87°07' W., 2,643.45 feet from the east quarter corner of said Section 28; thence along the following courses and distances: N. 39°16' E., 38.70 feet; thence N. 64°47' E., 1,011.84 feet; thence S. 68°33' E., 411.99 feet.

Ending at a point on the east boundary of the S $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ of said Section 28. Said point bears N. 71° 24' W., 1,393.64 feet from the east quarter corner of Section 28, Township 2 North, Range 4 West, Uintah Special Meridian.
