and other good and valuable consideration,

This conveyance is made with the distinct understanding and agreement that the grantees will dedicate the following described property, included in the above-described property to public use for a street, to-wit:

Commencing at a point at the NW Corner of the SW 1/4 of the SW 1/4 of Section 16, Township 4 South, Range 1 West, Salt Lake Meridian; thence running North 320 feet, thence East 50 feet; thence South 320 feet; thence West 50 feet to the point of beginning.

In the event that the Central Utah Water Conservancy District is unable to obtain an additional 16 feet from the property abutting said right of way to the West so that the dedicated street can be a total of 67 feet as provided in Agreement to Dedicate a Street recorded in the records of the Salt Lake County Recorder on October 2, 1968 in Book No. 2794 on Page 481, then the Grantees will dedicate the following additional described property conveyed to the Grantees to public use for a street, to-wit:

Commencing at a point 50 feet East of the NW Corner of the SW 1/4 of SW 1/4 of Section 16, Township 4 South, Range 1 West, thence running North 1130.92 feet, thence Southeast 17 feet; thence approximately 1130.92 feet to the North line of SW 1/4 of SW 1/4 of Section 16, Township 4 South, Range 1 West, thence West 17 feet to the point of beginning, together with any other property required to complete said public street.
