THAT DORAN HUPT CO., does hereby certify and declare that all of the lands of perel Subdivision shall be subject to the restrictions covenants and conditions, hereinafter expressed and that by the acceptance of any conveyance the grantee or Grantees therein, their and each of their heirs, executors, administrators, successors or assigns, as to any and all such property, will and do agree thereto.

- 1. Each and every lot shall be known as a "residential lot" and no structure or structures shall be erected, altered, placed or permitted to remain on any such residential lot other than a private garage for not more than three automobiles.
- 2. Each such dwelling bouse shall contain a minimum ground floor living area of not less than eight hundred (800) square feet, exclusive of porches or garages. Each such dwelling house shall be constructed at a cost of not less than lighteen thousand Dellars (\$18,000.00 or \$20,000 including lot, based upon current prices.)
- 3. No structure shall be erected, placed or altered on any such building lot until the building plans, specifications and plot plan showing the location of such structure have been approved in writing as to the conformity and harmony of external design and as to location of the structure with respect to tepography and finished ground clavation and as to conformity with all of the covenants, conditions and restrictions contained herein by a committee which shall consist of Doran Munt, Emil Pevel, John Pevel.

It event of the death of any member or members of said committee, the remaining member or members shall have the power and authority to appoint a successor. The committee shall, within thirty (30) days or as soon there after as is practicable, approve or disapprove any plans and specifications submitted to it in writing. In the event the committee does not set, such plans and specifications may be submitted to the Toocle City douncil for approval or disapprove any proposed building plan shall not in any way relieve the owner or the builder from his legal responsibility to somely with the covepants, conditions and restrictions contained herein.

- 4. The members of the committee thall serve without compensation, and the committee or any member thereof shall not be liable for its or his actions or decisions on any matter done pursuant to the provisions bereaf.
- 5. To structure shall be erected within this addition which does not conform with the reversi standards of the subdivision. Ensement dwellings, spraye dwellings, trailer bouses, tests, authorace, outhwildings, or spacks, are prohibited. To attricture of a temporary nature shall be used as a dwelling, either temporarily or permanently.

n. To structure shall be erected nearer than thirty(30) feet to the front residential lot line; however, customary architectural appartenances such as connices, say mindows, steps, spouts, chimneys; planter boxes, covered or uncovered porches, excluding enclosed porches, may extend an additional five (5) feet nearer the front lot line. No deciline house shall be located nearer than six (5) feet to the side line of a residential lot on one side and ton (10) feet on the other side; No nause or manage or other structure may be excepted or constructed measure than ten (10) feet be an existing building or simulate a litely affected or in the process of construction on any adjoining lot. No building or simulates shall be exected measure than five (5) feet to the team property lot like. No permanent structure shall be exected in team 10' of lots 18 through 26 unless ample drainage opening is provided. Mo residential structure shall be exected on any lot which has an area of less than six thousand (5,000) square feet.

7. No noxious or offensive trade or activity or illegal practice of any kind small be carried on open any residential lot or any part there of or in any building or structure or any part thereof, nor shall any activity be carried on which is or may become an ennovance of releaned to the occupants of the adjoining or remaining residential lots in this addition. In livestock, foul oriother animal or animals shall be kept for dementic or commercial use; provide, however, that household possible as cate or doze may be allowed if they are not victous, obnoxious or kept in excessive numbers.

2. To signs, billicards or advertising structure of any kind shall be exected or displayed on any residential lot or lots other than a single sign no more than two by two and one-half (2 x 2) fact in size advertising a specific lot or house for sale or rent, and said sign shall be placed only on the house or lot being so advertisely provided, however, that advertising signs by builders and materialmen will be allowed during periods of construction.

9. to trash, refuse, ashes or other rubbish may be dumped or thrown anywhere on This Addition.

10. Essements of live (5) foot are reserved on the back of each lot for utility installation and neintenance and for the use of drains or other purposes that may be necessary for the promotion of the health and general welfare of the inhabitants of the Addition.

all. The committee shall baye the gover by unanimous vote in individual cases to waive compliance with any of the coverants, conditions or restrictions contained herein in order to prevent undue hardship; provided, bowever, that if phy mafver is given it shall be reduced to writing and signed by all members of the committee.

12. All coverants, conditions and restrictions set forth herein shall run with the title to the land and be binding on all parties and persons claiming any interest is any of the land herein described or any part thereof.

17. The covenants, conditions and restrictions contained herein shall be in effect for a heriod of twenty-five (25) years from the date hereof, at which time said covenants, conditions and restrictions shall automatically be extended for successive periods of ten (16) years, provided that at the end of such twenty-five (25) year period or any such ten(18) year period the then owners of said residential lots may, by majority vote, amend, modify or nallify said covenants, conditions or restrictions. In whole or in part.

14. Any violation of the covenants, conditions and restrictions contained herein may be enjoined in a court of law or equity by the committee or by a majority of the owners of said residential lots, and any person violating said covenants, conditions and restrictions shall be liable for damages to the remaining owners.

- 15. The covenants, conditions and restrictions contained herein may be amended by the consistee at any time upon signed petition by the owners of a majority of the residential lots in the addition. Any such amendments made by the committee pursuant to such petition shall be effective only upon written approval by the owners of a majority of said residential lots. In computing a majority, each residential lot shall parry one (1) vote.
- 16. The coverants, conditions and restrictions contained herein are accepted by the incorporated city of Tooele. Tooele County, Utah and the property herein described is and shall be subject to all laws and ordinances of said city.

17. In the event any clause, sentence, paragraph or provision of the declaration shall for any reason be adjudged by any court of competent jurisdiction to be invalid, such judgement shall not affect, impair or invalidate the remainder but such judgement shall be confined in its operation to the clause, sentence, paragraph or provision thereof specifically held to be invalid.
