



EXHIBIT "A"

That EASEMENT and OPTION between MARY ANN M. ADAMSON, a widow, and UTAH CONSOLIDATED MINING COMPANY, dated October 8, 1908, and recorded October 12, 1908, in Book "B" of Liens & Leases, page 391, Records of Tooele County, Utah, and covering the following-described real property located in Tooele County, Utah, to wit:

Commencing at the Northeast Corner of the Northwest Quarter of Section 11, Township 3 South, Range 4 West, Salt Lake Base and Meridian, extending thence West 10 chains; thence South 2° West 20 chains; thence East 11 chains; thence North 20 chains to the place of beginning, containing 21 acres;

ALSO, Commencing at the Northwest Corner of the Southwest Quarter of the Northeast Quarter of said Section 11, extending thence East 43 rods; thence South 11-3/4° West 55 rods and 12 links; thence North 45° West 75 rods; thence East 20 rods to the place of beginning, containing 10 acres of land, more or less;
