APPLICATION FOR REALLOCATION OF PROJECT WATER

This Application for Reallocation of Project Water shall act as a suspension and transfer of certain Project Water, as outlined below. The following first described lands (the "Lands") have been allotted 1.0 acre-feet of Project Water by Petition and Order recorded as <u>E324065</u>, Book <u>398</u>, Page <u>643</u>, in the records of <u>DAVIS</u> County, Utah.
