295923 RIGHT OF WAY GRANT FOR WATER LINE

THOMAS LELAND FROST and Ruth S. FROST, his wife, as to an undivided one-half interest, and RAY L. FROST and Maud A. FROST, his wife, as to an undivided one-half interest, Grantors of Davis County, Utah, hereby

CONVEY and WARRANT to MUTTON HOLLOW IMPROVEMENT DISTRICT, a public corporation

of Utah, Grantee, of Davis County, Utah, for the sum of One (\$1.00) Dollar and other valuable considerations, receipt of which is hereby acknowledged, a perpetual right of way and easement for the purpose of digging a trench and/or making a fill along said right of way, to lay, construct, maintain, operate, repair, remove or replace a pipeline or pipelines, accessories and appurtenances therein for the transportation of water over and across Grantors' land and premises in Davis County, Utah, particularly describes as follows, to-wit:

A strip of land 10 feet wide lying five feet on each side of the following described center line, together with a temporary easement for construction purposes lying 5 feet to the left and 15 feet to the right of this centerline.

Beginning at a point 1960.9 feet East and 245 feet South of the Northwest corner of Section 25, Township 4 North, Range 1 West, Salt Lake Meridian, and running thence East 60 feet, more or less, to the West line of the proposed reservoir site.
