Temporary Easement

E.L.B. Properties, LC, a corporation of the State of Utah Grantor, hereby GRANTS AND CONVEYS to the City of West Haven, at 4150 South 3900 West, West Haven, Utah 84401, Grantee, for the sum of Ten (\$10.00) Dollars, and other good and valuable considerations, a temporary easement upon part of an entire tract of land situate in the SW1/4 NE1/4 of Section 2, T.5N., R.2W., SLB&M, West Haven City, Weber County, State of Utah to facilitate the construction of a pedestrian trail, known as The River Parkway Trail, Project No. F-LC57(30). This easement shall commence upon the beginning of actual construction on the property and shall continue only until project construction on the property is complete, or for three (3) years, whichever first occurs. This easement shall be non-exclusive, such that the Grantor may use the property at any time in a manner which does not interfere with construction activities. The boundaries of said easement are described as follows:


Beginning at a point 7.50 feet perpendicularly distant easterly from the control line of said project at Engineers Station 12+35.61, which point is 52.86 feet N.00°36'14"E. along the west line of the Northeast Quarter of said Section 2, and 15.00 feet N.90°00'00"E. from the Center Quarter of said Section 2; running thence N.00°36'14"E. 397.15 feet to the north line of said entire tract to a point 7.50 feet perpendicularly distant easterly from said control line at Engineer's Station 16+32.76; thence S.89°56'52"E. 1.50 feet along said north line to a point 9.00 feet perpendicularly distant easterly from said control line at Engineer's Station 16+32.77; thence S.00°36'14"W. 399.72 feet to a point 8.91 feet radially distant easterly from said control line at Engineer's Station 12+32.42; thence N.29°45'53"W. 2.97 feet to the point of beginning as shown on the official map of said project on file in the office of West Haven City. The above described easement contains 598 square feet or 0.014 acre in area.




