The UTAH DEPARTMENT OF TRANSPORTATION, by its duly appointed Director of Right-of-Way, Grantor, of Salt Lake City, County of Salt Lake, State of Utah, hereby QUIT CLAIMS to Sunrise 3, LLC, Grantee, at 1099 W South Jordan PKWY, South Jordan, County of Salt Lake, State of Utah zip 84095, for the sum of TEN (\$10.00), Dollars, and other good and valuable considerations, the following described tract of land in Davis County, State of Utah, to-wit:

A tract of land situate in the NE1/4NE1/4 of Section 34, T.2 N., R.1W., S.L.B.&M. The boundaries of said tract of land are described as follows:

Beginning at a point on the north boundary line of the Valentine Estates Phase 1 subdivision, according to the official plat thereof, recorded as Entry 2166825 in Book 4030 at Page 768, in the office of the Davis County Recorder said point is 28.97 feet N. 89°48'31" W. along the section line and 1238.25 feet S. 0°11'09" E. from the Northeast Corner of Said Section 34; and running thence N. 89°48'15" W. 950.48 feet along said north boundary line; thence N. 0°11'43" E. 14.40 feet; thence northerly

248.40 feet along the arc of a 1028.00-foot radius non-tangent curve to the left (Note: Chord to said curve bears N.  $6^{\circ}43'35''$  W. for a distance of 247.79 feet); thence S.  $89^{\circ}48'15''$  E. 541.97 feet; thence N.  $0^{\circ}11'09''$  W. 771.90 feet; thence S.  $83^{\circ}59'02''$  E. 239.94 feet; thence easterly 40.74 feet along the arc of a 467.00-foot radius tangent curve to the right (Note: Chord to said curve bears S.  $81^{\circ}29'06''$  E. for a distance of 40.72 feet) to a point of reverse curvature; thence easterly 104.41 feet along the arc of a 533.00-foot radius tangent curve to the left (Note: Chord to said curve bears S.  $84^{\circ}35'52''$  E. for a distance of 104.25 feet); thence N.  $89^{\circ}47'24''$  E. 29.08 feet; thence southeasterly 39.28 feet along the arc of a 25.00-foot radius non-tangent curve to the right (Note: Chord to said curve bears S.  $45^{\circ}11'53''$  E. for a distance of 35.36 feet); thence S.  $0^{\circ}11'09''$  E. 968.00 feet to the point of beginning. The above described tract of land contains 13.239 acres.

Together with and subject to any and all easements, rights-of-way and restriction appearing of record or enforceable in law and equity.

The grantor reserves rights to use the abutting state property for highway purposes and excludes from this grant any rights to air, light, view and visibility over and across the abutting state property. The Grantee is hereby advised that due to present or future construction on the adjacent highway including but not limited to excavation, embankment, structures, poles, signs, walls, fences and all other activities related to highway construction or which may be permitted within the Highway Right of Way that air, light, view and visibility may be restricted or obstructed on the above described property.

Junkyards, as defined in 23 United States Code, Section 136, shall not be established or maintained on this tract.

Signs, Billboards, outdoor Advertising structures, or advertising of any kind as defined in 23 United States Code, Section 131, shall not be erected, displayed, placed or maintained upon or within this tract, EXCEPT signs to advertise the sale, hire or lease of this tract or the principal activities conducted on this land.
