Tenants with full rights of survivorship and not as Tenants in Common
Grantor, of Syracuse, County of Davis, State of Utah, hereby
CONVEY AND WARRANT to the UTAH DEPARTMENT OF
TRANSPORTATION, Grantee, at 4501 South 2700 West, Salt Lake City, Utah
84114, for the sum of TEN (\$10.00) Dollars,
and other good and valuable considerations, the following described parcel of land in
Davis County, State of Utah, to-wit:

A parcel of land in fee for the widening of SR-108 (2000 West Street) known as
Project No. S-0108(33)4, being part of an entire tract of property situate in the
SW1/4 NW1/4 of Section 10, Township 4 North, Range 2 West, Salt Lake Base and
Meridian. The boundaries of said parcel of land are described as follows:

Beginning at the intersection of the existing easterly right of way line of said
highway SR-108 (2000 West Street) and the northerly boundary line of said entire tract,
which point is 1555.56 feet S.00°09'42"W. along the section line and 33.00 feet
N.89°56'27"E. from the northwest corner of said section 10; and running thence
N.89°56'27"E. 8.44 feet along said northerly boundary line to the point of curvature of a
non-tangent curve to the left with a radius of 7165.00 feet at a point 55.00 feet radially
distant easterly from the right of way control line of said SR-108 (2000 West
Street), opposite approximate Engineers Station 140+81.90; thence southerly along said
curve with an arc length of 97.61 feet, chord bears S.02°56'17"W. 97.61 feet concentric
with said right of way control line to the southerly boundary line of said entire tract at a
point 55.00 feet radially distant easterly from said right of way control line, opposite
approximate Engineers Station 139+83.54; thence S.89°29'15"W. 3.71 feet along said

southerly boundary line to said existing right of way line; thence N.00°09'42"E. 97.51 feet along said existing right of way line to the point of beginning as shown on the official map of said project on file in the office of the Utah Department of Transportation.

The above described parcel of land contains 581 square feet in area or 0.013 acre.
