the City of Weld, County of Weld and Territory of Colorado, record
owners of the property hereinbefore described, in Ralston, Weld
and William P. Thompson of the City of Denver, and James C. Clegg
of Greeley, State of Colorado, purchasers by contract of said
property, hereby declare that we are the owners of, and have
laid out and platted the following described premises situated
in the City of Weld, in the County of Weld, in the Territory of
Colorado and so to be named as "Rushton" for our particularity-to-it:
Part of the tenth last quarter of the tenth last quarter of Section
Twenty-eight-in Township six North of Range one East, Salt
Lake Division, Colorado, particularly described as follows:
Beginning at point fifty nine and six tenths feet east of the
tenth east corner of said tract of land, being the tenth line of
said tract running thence east four hundred and ten feet
thence east 1030 feet more or less to a point "A" east East
and due North 90 feet from the beginning point; thence east 100 feet;
thence North 100 feet to place of beginning.
