





UPON consideration of the Application for Informal Appointment of Personal Representatives filed by AUSTIN EASTMAN on December 31, 2024, the Registrar finds that:

1. The application is complete.
2. The applicant has made oath or affirmation that the statements contained in the application are true to the best of the applicants' knowledge and belief.
3. The applicant appears from the application to be an interested persons as defined by the Utah Uniform Probate Code.

4. The decedent, Brent Kay Eastman, died on October 14, 2024 at the age of 67 years.
5. On the basis of the statements in the application, venue is proper.
6. Any required notice has been given or waived.
7. On the basis of the statements in the application, no personal representative has been appointed in this state or elsewhere.
8. It appears from the application that the time limit for informal appointment has not expired.
9. The application does not indicate the existence of a possible unrevoked testamentary instrument which may relate to property subject to the law of this state, and which is not filed for probate in this Court.
10. Based on the statements in the petition, the person whose appointment as personal representative is sought is qualified to act as personal representative and has a prior right to appointment, or all others have waived their right to appointment.
11. Bond is not required.
12. The applicable time period within which no action can be taken on an application for informal probate and appointment has elapsed.

**THEREFORE:**

1. AUSTIN EASTMAN is hereby appointed as the personal representative of the decedent to act without bond.

2. Upon qualification and acceptance, letters testamentary shall be issued.
