DECLARATION OF CHANGE OF MEMBERSHIP

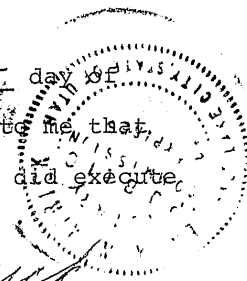
