called Grantee (whether one or more) ONE HUNDRED PER CENT (100%) interest in
 and to all of the oil, gas and other minerals in and under and that may be produced from the following described lands situated
 in Davis County, State, Utah to-wit:

BEGINNING 276 1/21 rods South of the Northeast corner of Section 34, Township 2 North,
Range 1 West, Salt Lake Meridian; thence South 820.0 feet, more or less to the South
line of Section 34, thence West along the South line of Section 34, to the Southwest
corner of said Section; thence North along the West line of Section 34, 820 feet to a

 homestead in the premises described herein, insofar as said right of dower and homestead may in any way effect the purpose for which
 this instrument is made, as recited herein.
