AMENDMENT TO CONDOMINIUM DECLARATION OF
THE LODGE AT SNOWBIRD

This Amendment to the Declaration of Covenants, Conditions and Restrictions of The Lodge at Snowbird, executed by the owners of units contained within The Lodge at Snowbird.

W I T N E S S E T H:

WHEREAS, Snowbird Ltd. executed a certain Declaration of Covenants, Conditions and Restrictions of The Lodge at Snowbird dated September 27, 1971, and recorded in the office of the County Recorder of Salt Lake County, State of Utah, as Entry No. 2412081 in Book 3001, pages 808, et seq. (hereafter designated the "Declaration"); and

WHEREAS, Snowbird Ltd. thereafter sold units in The Lodge at Snowbird to various purchasers of such units who thereupon became the owners of such units; and

WHEREAS, the Association of Unit Owners, on behalf of the owners, has purchased or will purchase condominium Units 111, 112, 113 and 114 in The Lodge at Snowbird, together with the improvements therein and their appurtenant undivided interests in the common areas as established and described in the Declaration; and

WHEREAS, it is the desire of the parties hereto to amend the Declaration as hereinafter provided, consistent with the provisions of the Declaration;

NOW, THEREFORE, the parties hereto, as owners of the property which is the subject of the Declaration, hereby agree as follows:

1. Units 111, 112, 113 and 114 of The Lodge at Snowbird may be commercial areas and may be operated for commercial shop space or as a restaurant, lounge or any combination of the foregoing, or for any purpose not inconsistent with the Declaration, which may be allowed by law. Anything in the Declaration which is inconsistent with the foregoing is hereby amended.

2. The Management Committee of the Association of Unit Owners of The Lodge at Snowbird may enter into a lease of Units 111, 112, 113 and 114 for the benefit of the Association of Unit Owners, may establish such rules and regulations concerning such units as in its discretion it deems appropriate, and to otherwise supervise and control the operation of the Units. The Management Committee may authorize structural alterations, additions and improvements in and to the Units, and to adjacent common areas and limited common areas, providing that easements and access through the common areas shall not be impaired.

3. This Amendment to the Declaration may be executed in one or more counterparts, each of which, when executed and delivered, shall be an original, and all of which
