SEC 070, LLC, a Utah limited liability company, Grantor hereby CONVEYS AND WARRANTS to the UTAH DEPARTMENT OF TRANSPORTATION, Grantee, at 4501 South 2700 West, Salt Lake City, Utah 84114, for the sum of TEN (\$10.00), Dollars, and other good and valuable considerations, the following described parcel of land in Weber County, State of Utah, to-wit:

A parcel of land in fee for the widening of the existing highway State Route 134 (2600 North Street) known as Project No. F-0235(20)3, being part of an entire tract of property situate in Lot 1, Barker Depot, a subdivision recorded as Entry No. 2992361, Book 85, Page 95 of plats, in the NE1/4 NE1/4 of Section 32, T.7N., R.1W., S.L.B.&M. The boundaries of said parcel of land are described as follows:

Beginning at the Northeast Corner of said Lot 1; and running thence S.01°06'46"E. 5.27 feet along the easterly lot line of said Lot 1 to a point in a 2,951.50-foot radius non-tangent curve to the left (Note: center bears S.02°35'21°W.); thence westerly along the arc of said curve 115.64 feet through a delta of 02°14'41" (Note: chord to said curve bears N.88°32'00"W. for a distance of 115.63 feet) to a point in the southerly right of way line of the existing highway State Route 134 (2600 North Street) said point is 55.00 feet perpendicularly distant southerly from said control line opposite engineer station 101+59.30; thence N.88°51'10°E. 115.51 feet along said southerly right of way line to the point of beginning as shown on the official map of said project on file in the office of the Utah Department of Transportation. The above described parcel of land contains 261 square feet or 0.006 acre in area, more or less.
