MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST dated June 14, 2017, is made and executed between SHONIK LLC, a Utah limited liability company, whose address is 675 NORTH MAIN STREET, FARMINGTON, UT 84025 ("Trustor") and Goldenwest Federal Credit Union, whose address is Corporate Branch, 5025 South Adams Ave, Ogden, UT 84403 ("Lender").

DEED OF TRUST. Lender and Trustor have entered into a Deed of Trust dated September 15, 2015 (the "Deed of Trust") which has been recorded in DAVIS County, State of Utah, as follows:

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in DAVIS County, State of Utah:

MODIFICATION. Lender and Trustor hereby modify the Deed of Trust as follows:

GOING FROM CONSTRUCTION LOAN TO LONG TERM LOAN; INCREASE LOAN AMOUNT FROM \$4,687,500.00 TO \$5,000,000.00; INCREASE INTEREST RATE FROM 4.50% TO 4.75%; GOING FROM INTEREST ONLY PAYMENTS TO MONTHLY PRINCIPAL AND INTEREST PAYMENTS OF \$26,100.00; EXTEND MATURITY DATE TO JUNE 15, 2027.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorers to the Note, including accommodation parties, unless a party is expressly released by

This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

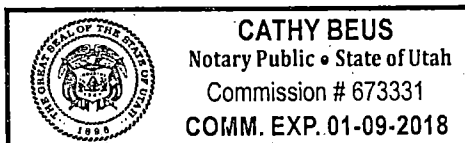

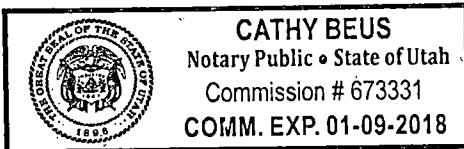
