DEED OF EASEMENT

IRVINE E. HUGHES, also known as Irvin E. Hughes and SYLVA F. HUGHES, also known as Sylvia F. Hughes, his wife, and HELEN S. HUGHES, a single woman of Farmington, County of Davis, State of Utah, hereinafter referred to as Grantor, hereby conveys to THE UNITED STATES OF AMERICA, acting pursuant to the provisions of the Act of June 17, 1902 (32 Stat. 388) and acts amendatory thereof or supplementary thereto, Grantee, for the sum of One Dollar (\$1.00), a perpetual easement to construct, reconstruct, operate and maintain an underground pipeline or pipelines and appurtenant structures which latter may protrude above the ground surface on, over or across the following described property in Davis County, State of Utah:

A tract of land in the Northeast Quarter of the Northwest Quarter (NE 1/4 NW 1/4) of Section Twenty-six (26), Township Three (3) North, Range One(1) West, Salt Lake Base and Meridian, being more particularly described as follows:

Beginning at a point on the Northeast corner of the Grantor's property, from which point the Northeast corner of said Section 26 bears North 77°55' East Twenty-eight Hundred Fifty-two and Four-tenths (2852.4) feet, and running thence South Fifteen (15.0) feet; thence West Thirty (30.0) feet; thence North Fifteen (15.0) feet; thence East Thirty (30.0) feet to the point of beginning, containing 0.01 of an acre, more or less.

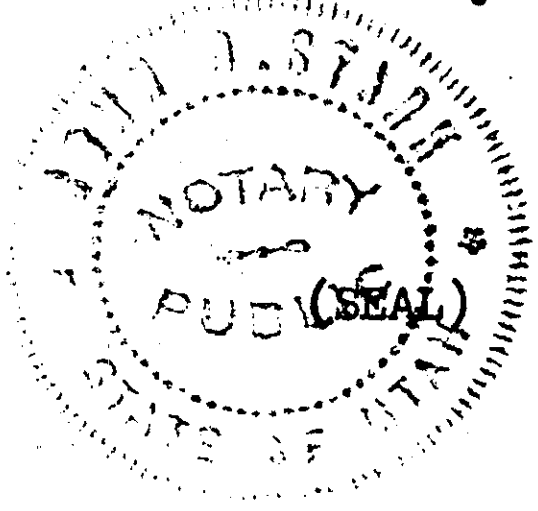
