FIRST AMENDMENT TO AMENDED AND RESTATED DECLARATION OF EASEMENTS AND CONDITIONS

RECITALS

This First Amendment is made with reference to the following facts and objects:

- 3. <u>Continuing Effect of DEC</u>. Except as modified by this First Amendment, all terms and conditions of the Original DEC shall remain in force and effect. In the event of a conflict between this First Amendment and the Original DEC, the terms of this First Amendment shall govern.
- 4. <u>Counterparts</u>. This First Amendment may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Signature pages may be detached from the counterparts and attached to a single copy of this First Amendment to form one document.
