

AMENDMENT TO DECLARATION OF BUILDING AND USE RESTRICTIONS Warrington

The undersigned, being all of the owners of Lots 201 through 257, Westwood Village No. 2, situate in Salt Lake County, Utah, do hereby amend Paragraph 4(a) of that certain Declaration of Building and Use Restrictions, recorded September 9, 1977 as Entry No. 2994238 of Official Records in Salt Lake County, Utah, covering said premises, to read as follows:

PART B. RESIDENTIAL AREA COVENANTS

Building Location.

(a) No building shall be located on any lot nearer to the front lot line or nearer to the side street line than the minimum building setback lines shown on the recorded plat. In any event no building shall be located on any lot nearer than 25 feet to the front lot line, or nearer than 20 feet to any side street line.
