## NOTICE OF ASSESSMENT

(SECONDARY WATER- MOUNTAIN VIEW IRRIGATION, INC.)

MOUNTAIN VIEW IRRIGATION, INC., (hereinafter referred to as Corporation), being duly organized and operating corporation in the State of Utah, does hereby state, stipulate and warrant the following:

- 1. Corporation has developed, built and owns a distribution system for the delivery of secondary water throughout portions of Weber County, State of Utah.
- 2. Attached hereto as Exhibit "A" is the legal description of a portion of the real property which is serviced by the secondary delivery system of the Corporation.
- 3. Notice is given to future owners and the present owners of the real property described on Exhibit "A" that they are subject to assessments, levied by the Corporation for the delivery of secondary water to the real property and for the maintenance, repair or replacement of the delivery system.
- 4. A connection fee is due to the Corporation prior to any delivery of secondary water which connects the subject property to secondary water delivery system.
- 5. In addition to the connection fee due to the Corporation an annual assessment will be imposed on the owners of the respective properties described on Exhibit "A" for the use of secondary water for that particular year.
