Less & Excepting: A parcel of land in fee for the widening of 300 West Street, known as Project No. STP-3328 (1)0, being part of an entire tract of property, situated in the Northwest Quarter of the Southwest Quarter part of Section 8, Township 5 North, Range 1 West, Salt Lake Base and Meridian. in Riverdale City, Weber County, Utah.
