RESOLUTION NO. 2002-4-1

A RESOLUTION TO ESTABLISH THE SOUTH SEVIER SPECIAL SERVICE DISTRICT, TO AUTHORIZE CONSTRUCTION OF IMPROVEMENTS AS SET FORTH IN THE NOTICE OF INTENTION TO CREATE THE DISTRICT AND TO APPOINT AN ADMINISTRATIVE CONTROL BOARD FOR THE DISTRICT.

WHEREAS, the Board of Commissioners of Sevier County, Utah, believes that the public health, safety and welfare require the construction of a system for the collection, treatment, and disposal of wastewater and sewage including collector and trunk lines, and to acquire necessary land, rights of way and an interest in treatment facilities as well as any other related facilities permitted for a special service district under Title 17A, Utah Code Annotated 1953, as amended, within a specified area, hereinafter particularly described, of Sevier County and therefore it is desirable to incorporate said area into a Special Service District pursuant to the provisions of the Utah Special Service District Act, Chapter 2, Title 17A, Utah Code Annotated 1953, as amended (the "Act"), and Article XIV, Section 8 of the Constitution of Utah; and

WHEREAS, none of the area to be contained within the boundaries of said proposed South Sevier Special Service District is also within the boundaries of any other special service district established by said County to operate a wastewater and sewage system or related services and facilities; and

WHEREAS, pursuant to the Notice of Intention Resolution adopted February 4, 2002, there was published in The Richfield Reaper, a newspaper of general circulation in the geographical area of the proposed special service district and designated as the official newspaper in that Resolution, a Notice of Intention to Create the South Sevier Special Service District on the 6th, 13th and 20th days of February, 2002; and
