RIGHT OF WAY DEED

THOMAS HIGGS, JR. AND ELSIE HIGGS, his wife grantors, of Ogden County of Weber State of Utah, hereby grants, bargains and sells to the State Road Commission of Utah, Grantee for the sum of One Hundred Fifty Two & 00/100 Dollars, the following described right of way across the grantors land in Weber County, State of Utah as follows: Right of way for highway known as F.A.S. Project No. 10 across the grantors land in the NE 1/4 SW 1/4 of Section 8 T. 6 N.R.1 W., S.L.M. said right of way is contained within a strip of land 50 ft. wide, on the east side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the North boundary line produced of said grantors land and said center line of survey at Engineers Station 286482 which point is 2297.0 ft. east along the south line of said Section 8 and 1567.6 ft. N. 0°54' E. along said center line of survey, from the SW corner of said Section 8; thence S.0°54' W 263.0 feet to the intersection of said center line of survey at Engineers Station 289445 and the south boundary line produced of said grantors land, which point is 2297.0 ft. east along said south section line and 1304.6 ft. N. 0°54' E. along said center line of survey from said SW corner of Section 8, as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described tract of land contains 0.30 acre, of which 0.17 acre is now occupied by other property owners. Balance 0.13 acre.

In executing this deed the grantor hereby grants to the State Road Commission of Utah permission to relocate and reconstruct within the grantors land and outside the limits of above described right of way all irrigation ditches existing within said limits of above described right of way. The purpose of this deed is to grant a perpetual right of way for highway purposes.
