Said right of way is contained within a strip of land 100 ft. wide 50 ft. on each side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the North boundary line of said grantors land and said center line of survey at Engineers Station 347+83 which point is 354.1 ft. west along the south line of said Section 17 and 772.7 ft.
