BEGINNING on the North line of 900 North Street, South 0° 05' East 519.5 feet and North 89° 58' West 675.92 feet from the Northeast corner of the Northwest Quarter of Section 20, Township 2 North, Range 1 East, Salt Lake Base and Meridian; thence North 0° 05' West 143.00 feet; thence North 89° 58' West 96.00 feet; thence South 0° 05' East 143.00 feet to a point on the North line of said 900 North Street; thence 89° 58' East 96.00 feet to the Point of Beginning.
