AN ORDINANCE OF THE WOODS CROSS CITY COUNIL ADOPTING AN AMENDMENT TO THE OFFICIAL PLAN FOR THE 2600 SOUTH COMMUNITY DEVELOPMENT PROJECT AREA, AS APPROVED BY THE REDEVELOPMENT AGENCY OF WOODS CROSS CITY, AND DIRECTING THAT NOTICE OF THE ADOPTION BE GIVEN AS REQUIRED BY STATUTE.

WHEREAS the Board of the Redevelopment Agency of Woods Cross City (the "Agency"), having prepared a draft amendment (the "Amendment") to the official Project Area Plan (the "Plan") for the 2600 South Community Development Project Area (the "Project Area"), the legal description of which is attached hereto as EXHIBIT A, and having held the required public hearing on the Plan on July 17, 2018, adopted the Amendment as an official amendment to the Plan; and

WHEREAS the Utah Limited Purpose Local Government Entities - Community Reinvestment Agency Act, Title 17C of the UCA (the "Act") mandates that, before the Amendment may take effect, it must be adopted by ordinance of the legislative body of the community that created the agency; and

WHEREAS the Act also requires that notice is to be given by the community legislative body upon its adoption of the Amendment.

NOW, THEREFORE, BE IT ORDAINED BY THE WOODS CROSS CITY COUNCIL AS FOLLOWS:

- 1. Woods Cross City adopts and designates the Amendment, as approved by the Agency Board, as an official amendment to, and an integral part of, the Plan (as amended by the Amendment, the "Official Plan").
- 2. City staff and consultants are authorized and directed to publish or cause to be published the notice required by the Act, at which time the Amendment and the Official Plan (as amended by the Amendment) will become effective.
- 3. Pursuant to the Act, the Agency may proceed to carry out the Official Plan upon its adoption.

4. This ordinance takes effect immediately.
