LEGAL DESCRIPTION

A PARCEL OF LAND LYING WITHIN SECTION 24, TOWNSHIP 2 NORTH, RANGE 1 WEST. SALT LAKE BASE AND MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE WEST LINE OF 500 WEST STREET, SAID POINT BEING NORTH 00°08'30" WEST 1943.51 FEET ALONG THE SECTION LINE, AND SOUTH 89°51'30" WEST 161.15 FEET FROM THE EAST QUARTER CORNER OF SECTION 24, TOWNSHIP 2 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, SAID POINT ALSO BEING NORTH 00°22'48" EAST 1547.01 FEET ALONG THE CENTERLINE OF 500 WEST STREET, AND NORTH 89°37'12" WEST 40.00 FEET FROM THE CENTERLINE MONUMENT FOUND AT THE INTERSECTION OF 400 NORTH STREET AND 500 WEST STREET; AND RUNNING THENCE NORTH 89°37'12" WEST 310.38 FEET; THENCE NORTH 65°05'01" WEST 29.67 FEET TO THE EASTERLY RIGHT-OF-WAY LINE OF INTERSTATE 15 AND A 2776.90 FOOT RADIUS CURVE TO THE RIGHT, (RADIUS BEARS SOUTH 64°20'25" EAST); THENCE ALONG THE ARC OF SAID CURVE 1.75 FEET; THENCE CONTINUING ALONG SAID EAST LINE THE FOLLOWING TWO COURSES: NORTH 27°58'50" EAST, A DISTANCE OF 277.61 FEET TO A U.D.O.T. RIGHT OF WAY MARKER ON SAID EAST LINE AND NORTH 32°30'37" EAST, A DISTANCE OF 245.40 FEET; THENCE LEAVING SAID EAST RIGHT OF WAY, SOUTH 89°35'53" EAST, A DISTANCE OF 67.50 FEET TO A U.D.O.T. RIGHT OF WAY MARKER ON THE WEST LINE OF 500 WEST LINE OF 500 WEST STREET; THENCE SOUTH 00°22'48" WEST, A DISTANCE OF 283.53 FEET ALONG SAID WEST LINE OF 500 WEST STREET; THENCE SOUTH 89°22'27" EAST, A DISTANCE OF 10.00 FEET TO A U.D.O.T. RIGHT OF WAY MARKER ON THE WEST LINE OF 500 WEST STREET; THENCE SOUTH 00°22'48" WEST, A DISTANCE OF 184.13 FEET ALONG SAID WEST LINE, TO THE POINT OF BEGINNING.
