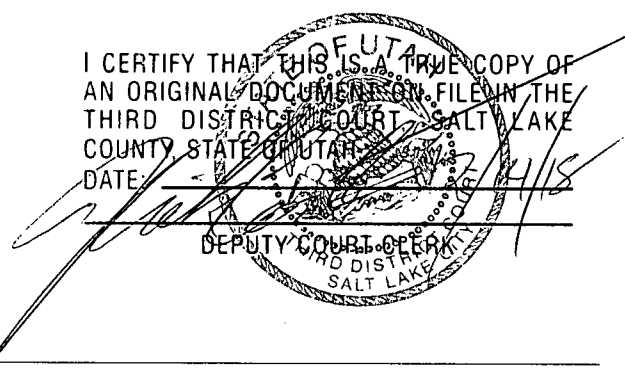

Plaintiff Security National Life Insurance Company's Motion for Summary Judgment having been submitted for decision before the Honorable Richard Mrazik; Defendants Chris Hansen and Paul Vorwaller having been properly served the same but having failed to respond in any fashion to said Motion; and the Court having considered and reviewed the Motion, Memorandum and Affidavit appearing in the court file of this case in support of the Motion at issue; and for good cause appearing, hereby

ORDER, ADJUDGES AND DECREES AS FOLLOWS:

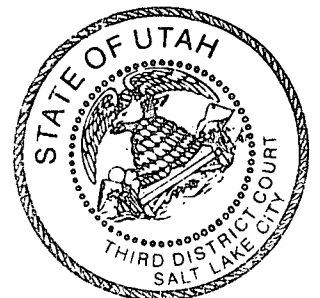
That summary judgment be awarded in favor of Plaintiff Security National Life Insurance Company and against Defendants Chris Hansen and Paul Vorwaller, jointly and severally, in the following amounts:

- 1) the principal amount due for the unpaid monthly Base Rent and Common Area Maintenance in the principal amount of \$21,695.62;
- 2) pre-judgment statutory rate of 10% per annum (per diem rate of \$5.94), accruing from the date of the breach (April 1, 2017) to October 12, 2018, in the amount of \$3,207.60;
- 3) court costs in the amount of \$472.00 (filing fee of \$360.00 and service fee of \$112.00); and
- 4) attorneys fees pursuant to Utah R. Civ. P.73(d) in the amount of \$775.00;

for a total judgment of \$26,150.22.

It is further ordered that the above judgment shall be augmented in the amount of interest at the post-judgment legal rate of 3.76% per annum continuing from the date of this judgment until paid, and also augmented with reasonable costs and attorneys fees expended in collecting said judgment by execution or otherwise pursuant to the provisions of the contract attached to the Complaint filed in this matter.

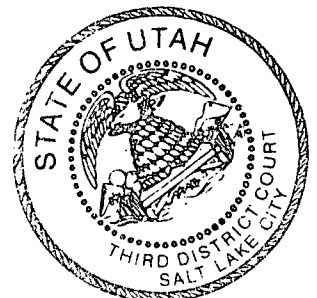


