FIRST AMENDMENT TO THE RESTATED AND AMENDED RIDGEWOOD OWNERS' ASSOCIATION BY-LAWS

This First Amendment to the Restated and Amended Ridgewood Owners' Association By-Laws is executed on the date set forth below by the Ridgewood Owners' Association (the "Association") having received the necessary approvals from the Owners.

RECITALS

- A. The Amended and Restated Declaration of the Ridgewood Owners Association (the "Association") was recorded in the Davis County Recorder's Office on September 5, 2014, as Entry No. 2522022 (the "Declaration").
- B. The Restated and Amended Ridgewood Owners' Association By-Laws were recorded in the Davis County Recorder's Office on March 22, 2018, as Entry No. 3082969 (the "By-Laws").
- C. This amendment affects the real property located in Davis County, Utah, described in Exhibit A.
- D. The Association desires to amend 7.2 of the By-Laws regarding the frequency with which an external audit is required.
- E. Pursuant to Section 15 of the By-Laws, the Unit Owners having ownership of not less than 51% of the Total Votes have signed an instrument consenting to this amendment (see Exhibit B, hereto).

NOW, THEREFORE, the Association hereby amends the By-Laws as follows:

Section 7.2 of the By-Laws are amended to state the following:

7.2 At the close of each fiscal year a review of the Association's books and records shall be conducted. The type of review shall alternate. For two consecutive years, the Management Board shall conduct an internal review of the Association's books and records. Every third year, the Association's books and records shall be audited by a certified public accountant approved by the Association.




