Stevens, his wife, Grantors, of Wasatch & Utah, Counties, Utah, hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and no guy anchors and 3 poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantor in Morgan County, Utah, along a line described as follows:

Beginning on the north boundary line of the Grantors' land at a point 1320 feet north and 678 feet east, more or less, from the west one quarter corner of Section 25, T. 4 N., R. 2 E., S. L. M., thence S. 37° 30' West 995 feet, more or less, to the south boundary fence on said land and being in the SW 1/4 of the NW 1/4 of said Section 25.
