VAL J. LUND and JANE I. LUND, his wife, ORIN L. LUND and BEVERLY S. LUND, his wife, and COTTONWOOD LAND COMPANY, INC., a Utah Corporation, GRANTORS, hereby convey to SALT LAKE CITY CORPORATION, a municipal corporation of the State of Utah, its successors in interest and assign, GRANTEE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, a permanent easement and right of the construction, operation, and continued maintenance, repair, alteration, inspection, relocation and replacement of a water main together with service lines, meters and all facilities attendant thereto over, under, across and through a tract of land located in Salt Lake County, Utah.

A sixteen foot permanent easement 8 feet on both sides of the following described centerline, together with a 25 foot construction easement 12.5 feet on both sides of the following described centerline:

Beginning at a point 844.7 feet South 89° 41' 22" East and 1319.8 feet North 0° 32' 52" West from the center of Section 34, Township 2 South, Range 1 East, Salt Lake Base and Meridian; thence East 232.9 feet, thence North 131.08 feet, thence North 63° 40' East 36.0 feet, thence South 52° 40' East 146.51 feet, thence South 63° 20' 03" East 116.8 feet to the West line of Oakcreek Estates Number 1, a subdivision located in the Northeast Quarter of said Section 34, also a 40 foot easement 20 feet on each side of the following described centerline: Beginning at a point 844.7 feet South 89° 41' 22" East and 1326.8 feet North 0° 32' 52" West from the center of said Section 34; thence South 0° 32' 52" East 480 feet more or less to the center of Little Cottonwood Creek.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement. Grantor retains the right to cross said tract of land with a roadway and will take all precautions necessary to protect any of Grantee's facilities contained therein.

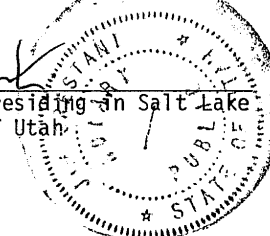

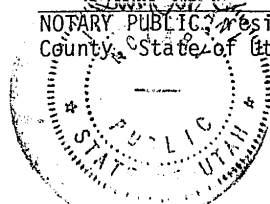
