Charles Poll and Vern C. Poll and their respective wives, Mrs C.H. Poll and Stella Poll, of Davis County, State of Utah, hereby conveys and warrants to the United States of America, its successors in interest and assigns, for the sum of One Dollar (\$1.00) and other valuable consideration, a perpetual easement and right of way for the construction and maintenance, repair, alteration and replacement of a pipe line for the conveyance of water to the Ogden Arsenal, to be constructed and maintained upon and across the premises of the grantor, in Davis County, Utah, along the line described as follows:

Beginning at a point approximately 20 feet South of the North West corner of the North East 1/4 of the North East 1/4 of Section 33, Twp. 5 North, Range 1 West, in Davis County, Utah, thence running due East to a point approximately 20 feet south of the North East corner of the North East 1/4 of the North East 1/4 of Section 33, Township 5 North, Range 1 West, Davis County, Utah.

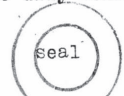
Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to excavate a trench on said right-of-way to a depth not to exceed five feet below the surface of the ground, provided that the grantor shall cause all excavated material to be properly backfilled and all disturbed ground to be left in as nearly its original condition as is consistent with good engineering practice, and finished work to be left in condition acceptable to the grantor.
