

Beginning at a point S 0° 14' E 688.65 feet along the Lot line and S 89° 22' 11" W 23.12 feet from the Northwest Corner of Lot 6, LaVerkin Townsite and Field Survey and running thence S 35° 10' W 121.25 feet; thence S 71° 18' E, 186.82 feet to a point on the West Right-of-Way line of State Highway U-9; thence S 21° 08' 45" W 370.67 feet along said West Right-of-Way line; thence N 65° 54' 44" W 147.42 feet to a point on the Center Section line of Section 26, Township 41 South, Range 13 West, Salt Lake Base and Meridian; thence N 89° 57' 10" W 233.87 feet along said Center Section line to the Southwest Corner of Lot 7, LaVerkin Townsite and Field Survey; thence N 0° 37' 49" W 440.00 feet along the West line of said Lot 7; thence N 89° 22' 11" E 399.92 feet to the point of beginning. Containing 4.431 acres.
