 of One Dollar (\$1.00), a perpetual easement to construct, reconstruct,
 operate and maintain an underground pipeline or pipelines and appurtenant
 structures which latter may protrude above the ground surface on, over or
 across the following described property in Davis County, State of Utah:

A tract of land in the Northeast Quarter of the Northwest
 Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Thirty-six (36), Township Two
 (2) North, Range One (1) West, Salt Lake Base and Meridian,
 being more particularly described as follows:

Beginning at a point on the Southwest corner of the Grantor's
 property, also being a point on the East right-of-way line of
 800 West Street, from which point the North Quarter corner of
 said Section 36 bears North 7°54' East Twelve Hundred Ninety-
 one and Two-tenths (1291.2) feet, and running thence North
 0°03' East Ten (10.0) feet; thence South 89°57' East One
 Hundred Fifty (150.0) feet; thence North Sixty (60.0) feet;
 thence East Ten (10.0) feet; thence South Seventy (70.0)
 feet; thence North 89°57' West One Hundred Sixty (160.0)
 feet to the point of beginning, containing 0.05 of an acre,
 more or less.
