Beginning at the intersection of the extension of a northerly boundary line of said entire tract and the easterly right of way line of Old Mountain Road of said Project, which point is 860.34 feet S.89°39'00"E. along the Quarter Section line and 324.67 feet North from the West Quarter corner of said Section 36; and running thence N.69°58'21"E. 14.42 feet along said northerly boundary line to a point 487.47 feet radially distant easterly from the US-89 right of way control line of said Project, opposite approximate Engineers Station 1146+69.26; thence S.07°39'35"E. 20.48 feet to the southerly boundary line of said entire tract at a point 487.71 feet radially distant easterly from the US-89 right of way control line of said Project, opposite approximate Engineers Station 1146+48.07; thence S.69°58'21"W. 4.92 feet along said southerly boundary line to said easterly right of way line at a point of curvature of a non-tangent curve to the right with a radius of 745.50 feet; thence northwesterly along said curve with an arc length of 20.65 feet, chord bears N.34°22'12"W. 20.65 feet to the point of beginning as shown on the official map of said project on file in the office of the Utah Department of Transportation.



The matter of the Verified Petition to Modify Trust Agreement having come on regularly for hearing on the 21st day of August, 2019, and the Court having reviewed the petition and the other submissions in the file, and being fully advised in the matter, the Court now makes the following

FINDINGS AND CONCLUSIONS

a. Petitioner, Inez Barker, is the surviving trustor of The John Forest Barker and Inez F. Barker Loving Trust, dated July 28, 1993 (the "Trust Agreement"), John Forest Barker having died on November 21, 2018.

- b. This court, pursuant to Utah Code Ann. Sections 75-1-301 (1992), 75-1-302 (1975) and 75-7-201 (2003), has jurisdiction of the subject matter relating to the Trust Agreement.
- c. Venue is proper in this court under Utah Code Ann. Section 75-7-205 (2004) because the trust's principal place of administration is in Davis County, and the trustee, and petitioner herein, resides in Davis County.
- d. The trust operates for the benefit of the trustors and the trustors' children.
- e. An amended and restated Trust Agreement was prepared for joint execution by John Forest Barker and Inez F. Barker, prior to John's death, but was unsigned prior to John Forest Barker's death, leaving the original trust agreement irrevocable.
- f. On April 29, 2019, the Trust Agreement was formally amended and restated again (the "Restated Trust") by Inez Barker as the surviving trustor, and the present Petition filed under Utah Code Ann., Section 75-7-411(1).
- g. The proposed change in the Restated Trust is consistent with the trustors' purpose for the trust.
- The Restated Trust provides for the Petitioner as beneficiary and for the contingent beneficiaries.
- That the amendment and restatement of the trust does not constitute a

- material change in the trust.
- j. Each of the beneficiary and contingent beneficiaries have consented to the amendment as indicated by the Consent to Amendment and Restatement of Barker Family Trust (the "Consent Documents") on file with the Court.
- k. That all parties, beneficiaries, and contingent beneficiaries were represented by counsel or, being advised of the right to employ counsel, elected not to do so.
- Notice of hearing has been given to all interested individuals.
 WHEREFORE, the Court Orders as follows:
 - a. That the amendment and restatement of The John Forest Barker and Inez F. Barker Loving Trust, dated July 28, 1993, as amended into the Amended and Restated Barker Family Trust, dated April 29, 2019, is hereby ratified.
 - b. That the trustee is authorized to pay the legal costs of this action, and related legal expenses to Inez' counsel, and other parties are to pay their own legal fees and costs, if any.
