1. EASEMENT

The National Filter Media Corp. a corporation doing business in the State of Utah, Grantor, hereby conveys to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection, operation and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission and distribution circuits of the Grantee, with the necessary poles, towers, guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said circuits, on, over and across a tract of land located in Salt Lake County, Utah along the following described center line:

Beginning at the east boundary line of the Grantors' land at a point 34 feet north, more or less, from the northeast corner of Lot 6, Block 137, Plat "A", Salt Lake City Survey, thence West 308 feet, more or less, thence S.81°53'W. one foot, to the west boundary fence of said land and being in vacated 6th North Street between Blocks 137 and 152 of said Plat "A".

This easement cancels and supersedes that certain easement dated February 13, 1964 and recorded August 20, 1964 as Instrument No. 2021560 in Book 2226 at Page 361 in the office of the Recorder of Salt Lake County, State of Utah.
