


EXHIBIT "A"

PARCEL 1 06-097-0026

The South half of Blocks 1, 2, 3, 4 and 5 and Lots 7 and 8 Block 6, Plat F, GARLAND TOWNSITE SURVEY.

PARCEL 2 06-098-0015

Beginning at a point 330 feet South of the Northeast corner of the Northwest Quarter of Section 35, Township 12 North, Range 3 West, Salt Lake Base and Meridian; thence West 2200 feet; thence South 66 feet; thence West 66 feet; thence South 297 feet; thence East 2266 feet; thence North 363 feet to the place of beginning.

Less: Part of the Northwest Quarter of the Northwest Quarter of Section 35, Township 12 North, Range 3 West, Salt Lake Base and Meridian, described as follows: Beginning at the Southwest corner of Lot 5, Block 6, Plat F, GARLAND CITY SURVEY, and running thence East 148.5 feet, more or less to the West bank of an existing irrigation ditch; thence South 66 feet more or less following the West bank of said ditch to a point where said ditch turns West; thence West 148.5 feet, more or less following the North bank of said irrigation ditch to the East line of 100 East Street (Mayfield Avenue); thence North 66 feet more or less to the point of beginning.
