Thence southwesterly 7.04 feet along the arc of a 932.80 foot radius curve to the left, (center bears South 40°41'20" East and long chord bears South 49°05'41" West 7.04 feet, with a central angle of 0°25'56") along the north line of 3100 North Street and the south line of said Lot 30;

Thence North 34°58'27" West 104.10 feet to the north line of said Lot 31;

Thence North 62°49'30" East 10.09 feet along the north line of said Lot 31;

Thence South 34°58'27" East 101.71 feet to the north line of 3100 North Street and the south line of said Lot 31;
