
The purpose of this affidavit is to correct an error made in the Section designation of an Ingress and Egress Easement and Right-Of-Way recorded as Entry No. 92903:2012 in the office of the Utah County Recorder.

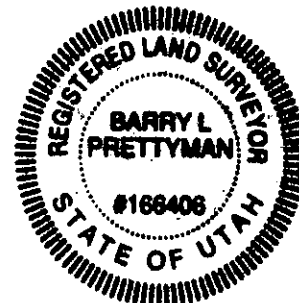
The Section is designated as Section 25, Township 10 South, Range 4 East, Salt Lake Base and Meridian, the Section should be Section 5, Township 10 South, Range 4 East, Salt Lake Base and Meridian. The correct description is as follows:

A 26 foot wide Easement and Right-Of-Way, 13 feet wide on each side of the following described centerline:

Beginning at a point on the West Line of Highway 89 and the Southeast Corner of Lot 2, Crab Creek Estates, Plat "A", which point lies South 89°51'57" West 1089.72 feet along the Section Line and South 2144.62 feet from the Northeast Corner of Section 5, Township 10 South, Range 4 East, Salt Lake Base and Meridian; and running along the South Line of said Lot 2 and the centerline of an existing gravel road all of the following courses to wit: North 41°01'33" West 48.25 feet; North 39°43'42" West 50.75 feet; North 34°34'34" West 55.87 feet; North 20°39'32" West 56.85 feet; North 14°36'34" West 53.82 feet; North 17°44'48" West 52.57 feet; North 31°57'33" West 51.03 feet; North 52°14'00" West 53.91 feet; North 64°29'47" West 57.47 feet; North 86°02'18" West 51.54 feet; South 82°50'07" West 50.81 feet; South 80°51'07" West 55.50 feet; South 78°25'07" West 55.21 feet; South 78°43'08" West 57.53 feet; South 80°05'11" West 51.24 feet; South 82°58'08" West 54.96 feet; North 88°59'47" West 61.14 feet; North 72°53'37" West 67.02 feet.


